TO THE COMMON COUNCIL of the City of Shawano, Shawano County, Wisconsin.

I, the undersigned, do hereby respectfully make application to the Common Council of the City of Shawano, for a milk license for the year ending June 30, 20____.

I certify that I am a resident of the United States and that I have not been convicted of a felony within one year from the date of this application.

11.03 SALE AND DISTRIBUTION OF MILK AND MILK PRODUCTS

(1) No person shall sell or distribute milk, or any milk product, as hereinafter defined, for direct human consumption or to any hotel, restaurant, store, vendor or other retailer for resale for human consumption unless such person possesses a valid license therefor granted by the City of Shawano. No license shall be required for hotels, restaurants, stores, vendors and other retailers who sell the milk and milk products furnished by licensees in compliance with this ordinance.

(2) Each application for a license shall state the name and address of the person applying for the license and the location of the premises where any item regulated by this ordinance is bottled, pasteurized or otherwise prepared for distribution. The license shall be issued by the City Clerk-Treasurer upon payment of a fee of \$25.00 for each year or fraction thereof. The license term shall extend from July 1st to June 30th of the following calendar year.

(3) The term "Milk Product" shall mean and include cream, homogenized milk, buttermilk, skim milk, milk beverages, skim milk beverages, milk or skim milk which have been fortified by the addition of vitamins or minerals and any other product made by the addition of any substance to milk or any of these named products and used for the same purposes, which may be designated by the Common Council as a milk product.

(4) It shall be unlawful to sell, offer or expose for sale any milk or milk product which is adulterated or misbranded as those terms are defined in the Wisconsin Statutes.

(5) No person shall sell, offer or expose for sale any milk or milk product other than Grade A pasteurized milk or milk products as those terms are defined in Wisconsin Administrative Code, chapter Agriculture 80, issued by the State Department of Agriculture, a certified copy of which is filed in the office of the City Clerk.

I hereby agree if granted said license, to obey all provisions of the above laws of the Municipal Code of the City of Shawano.
